

# ALBANY COUNTY LAND BANK REAL PROPERTY DONATION POLICY

#### **SECTION 1. PURPOSE AND AUTHORITY.**

The purpose of this Policy on the Donation of Real Property (the "Policy") is to set forth the requirements applicable to the acceptance by the Albany County Land Bank Corporation (the "Land Bank" of "ACLB") of real property which is proposed to be donated to the Land Bank. This Policy expands upon the Land Bank's Real Property Acquisition Policy as it pertains to donated properties.

#### **SECTION 2. DEFINITIONS.**

As used herein, the following terms shall have the meaning set forth below.

- A. "Board" shall mean the Board of Directors of the Land Bank.
- B. "Chair" shall mean the Chair of the Board.
- C. "Executive Director" shall mean the Executive Director of the Land Bank, or in the event of a vacancy, the Chair.
- D. "Land Bank" or "ACLB" shall mean the Albany County Land Bank Corporation.

### **SECTION 3. CRITERIA FOR DONATION OF REAL PROPERTY.**

- A. ACLB may accept donations of real property subject to the discretion of the Board.
- B. The acquisition of real property by the ACLB is limited to real property that is tax delinquent, tax foreclosed, vacant, abandoned, or for which acquisition is consistent with an approved redevelopment plan prepared by the ACLB.
- C. Prior to recommending to the Board that the ACLB accept title to property, the Land Bank shall evaluate:
  - i. Whether the property possesses potential for redevelopment that furthers the goals and objectives of the ACLB;
  - ii. Proximity to other real property owned by the ACLB;
  - iii. Potential for combining the property with adjacent properties, whether such property is currently owned by the ACLB or under consideration to be acquired by the ACLB;
  - iv. Proximity to targeted redevelopment plans;
  - v. Whether the property is occupied;
  - vi. Whether any taxes are owed, or liens are filed against the property;
  - vii. Whether there are defects in title and the ability to obtain title insurance;



- viii. Condition and market value of the property;
- ix. Cost to remediate hazards or nuisances posed by the property;
- x. Whether the property is accompanied by a cash donation [to mitigate the costs of ownership and redevelopment];
- xi. Cost to fully redevelop the property;
- xii. Financial resources available to redevelop the property;
- xiii. Whether there exists an interested buyer or similar factors related to marketability.
- D. A Phase I environmental assessment may be required depending on the type and location of the property. The cost of a Phase I environmental assessment, if requested, is the responsibility of the potential donor; provided however, if the Board determines that the property is of strategic importance to the ACLB and the donor demonstrates financial hardship or inability to pay for the Phase I assessment, the ACLB may agree to bear this cost.

#### **SECTION 4. BOARD APPROVAL AND ACCEPTANCE**

- A. Upon a recommendation by the Executive Director to accept property, the Board shall undertake meaningful analysis to determine whether acceptance of such donation is in the best interest of the ACLB.
- B. ACLB will not determine a donation value for the purpose of tax benefits, but the Executive Director shall be authorized to provide a letter describing the property donated as a contemporaneous written acknowledgement under section 170(f)(8) of the Internal Revenue Code.

#### **REAL PROPERTY DONATION FORM**

Thank you for your interest in donating a property to the Albany County Land Bank Corporation (ACLB).

The Albany County Land Bank was established in 2014 by Albany County to facilitate the process of acquiring, improving, and redistributing tax-foreclosed, vacant or abandoned properties. While ACLB's Focus Neighborhoods are located in the City of Albany, we are open to considering donations of properties throughout Albany County. The Albany County Land Bank is a tax-exempt 501(c)3 non-for-profit corporation committed to revitalizing neighborhoods and strengthening communities throughout Albany County.

Donation considerations are subject to the ACLB's Real Property Donation Policy and reviewed by the ACLB's Acquisition and Disposition Committee. All donations must be approved by the ACLB's Board of Directors. The Albany County Land Bank can only accept lien-free properties that you own outright. We cannot accept properties that still have a mortgage. The donor will be responsible for paying past and current real estate taxes due. The property must be vacant and unoccupied at the time that you submit this form.

We ask that the applicant understands and acknowledges that ACLB may require the current owner to acquire and submit additional information about the property, including environmental assessments and reports. In addition, there are certain costs associated with the donation of a property that may include, but not be limited to:

- Attorney Fees
- Deed and Document Preparation
- Record Fees
- Past Due Water/Sewer Bills
- Title Searches
- Abstracts
- Surveys
- Title Insurance
- Inspection reports or testing as requested by ACLB
