

# **Acquisition and Disposition Committee Meeting Minutes**

A public meeting of the Acquisition and Disposition Committee of the Albany County Land Bank Corporation was convened on January 12, 2022, via audioconference in accordance with New York State law.

The meeting was called to order at 3:07 PM

#### **Review of minutes:**

The minutes of the December 15, 2021, Acquisition and Disposition Committee meeting were reviewed and approved with one change: amending the title to correctly note that a public meeting of the "Acquisition and Disposition Committee" was convened, rather than "Finance Committee" as stated on the draft minutes.

#### **New Business:**

Multiple pre-closing requests received by the staff were presented to the A&D committee for consideration:

- a. 464 Elk Street approved buyer seeks a payment plan to purchase this lot. Buyer has pending issues, and this request was not considered this month
- b. 598 Third Street request from approved buyer to subordinate for a bank loan prior to closing, approved
- c. 35 Lark Street request from approved buyer to subordinate for a bank loan prior to closing, approved
- d. 45 Ontario Street request from approved buyer to subordinate for a bank loan prior to closing, approved
- e. 202 Myrtle Avenue, prior approved buyer that did not close, would like to reactivate and move forward. Does not have financing currently in place, rejected

Donation of 33 North Street, Albany, New York. A request for a property donation was received. The Committee agreed the land bank would see no value to accepting this donation and recommended that staff suggest the buyer seek out adjacent landowners for a possible disposition.

A new program structure was presented for discussion. It would encourage eligible buyers to purchase vacant lots for a fixed purchase price, not the offer price plus closing costs. Different ideas were discussed, and Land Bank Staff will continue to refine the proposed program based on the feedback received and program goals.

The South End Co-Development Revitalization Initiative continues to move forward. The project team meets weekly. The project involves over 60 vacant lots with single family homes planned for Broad Street and Liebel Street and multifamily designs are undergoing final revisions before updates will be provided to elected officials, partners, and community stakeholders.

The responses to the Henry Johnson Boulevard / Clinton Avenue RFP have been review by the RFP Selection Committee which consists of Land Bank and City of Albany staff. The Selection Committee will continue to work together to advance the procurement process.

Staff continues to draft the Ontario and West Street redevelopment RFP. The RFP is expected toe be released in late spring or early summer.
