#### **Review of Minutes:**

The minutes from the April 2021 Acquisition and Disposition Committee meeting were reviewed and approved as presented.

# Land banking multiple properties in connection with a vacant building rehabilitation and neighborhood revitalization pilot program:

The Land Bank is currently working with the Community Preservation Corporation to identify properties for a pilot program to rehab Land Bank buildings into move-in ready homeownership units using New York State funding. The Land Bank is also working to identify local contractors who can complete these rehabs to be involved in this pilot program. The Executive Director requested that approximately 30 buildings be banked for further review of viability to support such a program. Upon discussion from members of the Committee, the Land Bank will bank the properties for the program and the Committee will be updated on the status of the potential pilot program at the June A&D meeting.

## 1297 Broadway, Watervliet NY:

The Land Bank approved an applicant to purchase 1297 Broadway in the City of Watervliet at a prior Board meeting. Since the approval, the approved buyers have requested to materially change their proposal for the property due to financing considerations. Since the sale of the property was approved by the Board at least one other party has expressed interest in applying to purchase the property. There was also an alternate buyer approved by the Board of Directors. Land Bank staff will contact the alternate buyer to see if they are still interested in proceeding with the acquisition.
